## Updates

- **Phase II Hiring.** DOE has made a contractor selection and is in the Congressional notification stage, which is required by statute. DOE expects to be able to make an announcement on June 22, and if all goes well, the contractor could be available for the July meeting.
- **Past Year Budgets.** Steve has been working with DOE budget staff and several Trustees to finalize the budgets for past years, including carry-over amounts. Completed spreadsheets should be available for Trustee review prior to the July meeting for discussion at the meeting.
- **Annual Retreat.** Information on the hotel and reservations was previously sent out by Teresa, and John is working on getting us conference rooms. We will assume for now that one of the State agencies will provide a projector, conference phone, etc. The final schedule is not yet set until we have an agenda for that meeting and discuss possible additional activities we might want to do.
